Students should arrive at the stop at least 10 minutes before pick-up time. Enter the bus in a safe manner, buckle seat belts and remain seated.

Parents must notify the school and the Transportation Secretary, Christine Unish (732-574-9600, ext. 3352) with any change in phone numbers, and addresses. Parents are responsible for the safety of students until they board the bus. Please allow a 10-minute window for the bus to reach the stop. Buses can be delayed for unforeseen circumstances (weather, traffic, etc.)

### When Buses Are Late

To report late buses, morning or afternoon, items left on the bus by students, or any other bus related problems, call the school secretary, Diane MacAvoy at 732-381-0400, ext. 4100 and Christine Unish, transportation secretary at 732-574-9600, ext. 3352. Mrs. Unish will contact the bus company regarding the problem and will contact parents with an explanation.

**Please Note**

Only those students who were determined to be eligible for busing will be able to ride the bus. The state's eligibility requirement for K-8 students is living 2 miles or over from the school.
