We are pleased to inform you that UNIONDALE UFSD will be continuing a meal certification option available to schools participating in the National School Lunch and School Breakfast Programs for 2019-2020. Once again, we will be offering free breakfast, lunch and after school snacks to all students in Uniondale public schools on all days of session. This program is funded primarily by the Federal government with a small contribution by New York State.

### What does this mean for your child(ren) attending the school(s) identified above?

All students enrolled at ALL UNIONDALE PUBLIC SCHOOLS are eligible to receive a healthy breakfast and lunch at school at **no charge** to your household each day of the 2019-2020 school year. No further action is required of you. Your child(ren) will be able to participate in these meal programs without having to pay a fee or submit an application.
