SUPERINTENDENT'S UPDATE

Dr. William K. Lloyd stated that for months, the Board has been meeting and reviewing various scenarios for building and expanding the District's facilities. This evening there will be a complete review of the plans and the Board will be voting on the final decision.

A power point was shown and the architect, Jason Smith, and Central Administrators each spoke on their particular topics.

Mr. Georges expressed his concern with 127 additional classroom district-wide and that it seems to be excessive. He asked for an estimate of the number of staff we would require and the effect on the annual budget.

Comments, questions and concerns regarding feeling that we presently do not have enough classrooms and are understaffed. Specifically with less students we had three social workers and 4 Assistant Principals, with the increased staff we have two social workers and 3 Assistant Principals at the high school; next year is the last Pre-K in the grant, and we need additional room to bring the students to Uniondale; California Avenue and Northern Parkway Elementary Schools are both congested.

There is a concern with the number of renters who do not pay taxes but have children in our schools. There was a request for 3-dimensional, on-line photos of the projects. They asked how

they could sell the project to taxpayers. There was a concern with a report from the State Education Department's response to questions about the Smart Bond, but Administration assured the public that the money was ours and we were waiting to apply it to the Building Project. However, there was a feeling that we have lost opportunities to get monies. Questioning if administration could forecast a guaranteed 59% business and 41% homeowner tax share. If this evening the entire resolution was being adopted. These comments were made by Addie Blanco Harvey, Nikki Holman, Barbara Ford, Olga Hernandez and Paul Incarnato.

Mr. Clarence Little gave the Treasurer's Report as well as the Financial Report. Mr. Georges asked that the Board meet with Mr. Little.

COMMENTS BY THE BOARD:

Ms. Campbell mentioned that the food in the new lunch program was not as good as previously offered. She also mentioned an Enrichment Program that did not have access to laptops but was reassured that they would be getting access.

Dr. Mangum mentioned that she has been reading newspapers after the hurricanes in Puerto Rico and Virgin Island. It will take them a long time to recover and the children are being sent to Florida, New Jersey and New York. There is a good possibility that we will be getting some of these children and asked that Administration prepare to receive them. Dr. Mangum mentioned that they had met with Mr. Kreiger, developer of the A. Holly Patterson property and they will be adding new members to the Uniondale Community but not students.

Mr. Georges stated that Puerto Rico and the Virgin Islands are in bad shape and we can expect a large influx of those coming to New York. He feels we do need to add space but we need to go about this in a fiscally responsible way. It cannot be done overnight. We need to consider the community and \$200,000,000. approximately is a large burden. We should only consider needed items. We need to consider the annual budget and how it will be affected. We have many foreclosures and zombie homes in our District.

Mr. Georges asked what happens when a student cannot pay for music instrument rental.

Mr. Cubas stated that we are opening doors for the future for our students. We are working hard to improve our schools and what we are doing is for the future. We are proud to present this project to our community. No matter what we do, our budgets will increase due to salaries, pensions, etc. This is beneficial for our students and our community.

Mr. Sharpe introduced a previous student Board Member and sister of our present student Board Member, Ariana Campbell. He thanked her for her service. He was disappointed that the lunch program is not successful. He expected it to stay the same, not to go down. He asked that PTA arrange to observe the lunch program. He mentioned we do not have enough space now in our schools and what are we going to do in the future. We cannot stay stagnant.

Mr. Mott stated that we will be receiving \$250,000 from Mr. Kreiger, Developer of A. Holly Paterson property. The Board had met with him and he will be building two bedroom two bathroom homes for those 55 and over and 180 units for Millennia. They do not expect to have a large influx of children from their buildings. Our demographic study indicates a 6.4% increase. We do not know what will happen but we are planning for the expansion.

COMMENTS BY THE PUBLIC:

Comments, questions and concerns regarding concern for safety in schools; when IEP expires who looks into it for the student; hiring staff that will have a better impact on student behavior; we need to hire more we do not have enough staff, especially a social worker; the need for a class study hall; free periods students roam the halls; we need to generate money and start with the most needed improvements; when is the Board going to vote for the particular project; thanks for the presentation of a plaque; how to get off the connect-Ed list; were raised by Addie Blanco Harvey; Paul Incarnato; Olga Hernandez and Barbara Ford.

WHEREAS, the District directs that the District architects/engineers notify, as appropriate, involved and interested agencies under SEQRA of the District's intent to act as lead agency for the coordinated environmental review of the Project under SEQRA to such agencies together with the Resolution of the District's intent to act as lead agency for the SEQRA review of same, and if no objection to the District acting as lead agency is upheld in accordance with applicable law, then the District shall act as lead agency in order to conduct a coordinated environmental review under SEQRA for the Project.

BE IT RESOLVED, that the District hereby directs its architect/engineer to provide the involved agencies and interested agencies for the Project (list attached) with a copy the Full EAF for the School District Improvements and a copy of this resolution that the District intends to act as the lead agency in order to conduct a coordinated environmental review for the Project under the New York State Environmental Quality Review Act; and

BE IT FURTHER RESOLVED, that if no objection to the District acting as lead agency is received within thirty (30) days, then the District will declare itself as lead agency for the SEQRA review of the Project and conduct a coordinated environmental review for same in accordance with 6 NYCRR. 617.1 et seq. of the implementing regulations under the New York State Environmental Quality Review Act as well as Article 8 of the New York Environmental Conservation Law.
