Mr. Grieco , President, opened the April 3, 2013 Board of Education meeting at approximately 7:33 pm in the WMS/WHs Library. At approximately 7:34 pm, the resolutions below were acted upon by the Board of Education.

**A) APPROVAL – MEMORANDUM OF AGREEMENT, CIVIL SERVICE EMPLOYEES  
UNION LOCAL 1000, MT. PLEASANT CLERICAL UNIT**

Motion made by Mr. Grieco, seconded by Mr. Schulze, as follows:

BE IT RESOLVED: That the Board of Education herewith adopts and authorizes a certain Memorandum of Agreement between the Mt. Pleasant Central School District and the Civil Service Employees Union Local 1000, Mt. Pleasant Clerical Unit, for the period of July 1, 2012 through June 30, 2015.

BE IT FURTHER RESOLVED: That the Board of Education authorizes its attorneys to incorporate said Memorandum of Agreement into a successor collective bargaining agreement.

**B) APPROVAL – MOUNT PLEASANT TEACHERS’ ASSOCIATION RETIREMENT  
INCENTIVE PLAN**

Motion made by Mr. Grieco, seconded by Mr. Schulze, as follows:

**BE IT RESOLVED:** That the Board of Education of the Mount Pleasant Central School District hereby authorizes and approves a certain side letter agreement between the Board and the Mount Pleasant Teachers’ Association, dated April 3, 2013, providing for a retirement incentive for eligible teachers for the 2012/13 school year. The Board has previously reviewed said agreement in Executive Session.

**VOTE: 6 – 0**
