BY AND BETWEEN THE YOUGH SCHOOL DISTRICT, with offices located at 915 Lowber Road, Herminie, Westmoreland County, Pennsylvania, 15637-1219 (hereinafter referred to as "District"),

THOMAS EVANS, an individual residing at 931 McKean Avenue, Donora, Washington County, Pennsylvania, 15033 (hereinafter referred to as "Evans"),

WHEREAS, Evans is currently employed as the Districts Athletic Director; and

WHEREAS, the District wishes to also employ Evans as Athletic Director for the term of five (5) years from July 1, 2016 through June 30, 2021 at a rate of Twenty One Thousand Five Hundred Dollars (\$21,500.00) per annum, payable in twenty-four (24) equal installments.

NOW, THEREFORE, the parties intending to be legally bound and in consideration of the mutual covenants contained herein do hereby agree as follows:

1. **Compensation.** Evans will serve as Athletic Director at a salary of Twenty One Thousand five Hundred Dollars (\$21,500.00) Dollars per annum upon satisfactory evaluation and approval by the Yough Board of School Directors. The Athletic Director is eligible for a salary increase up to three (3%) percent per annum by the Yough Board of School Directors.

2. **Duties.** The Athletic Director will perform the duties as described in Exhibit "A" attached hereto and made a part hereof.

3. **Severability Clause.** Should any term, condition or provision of this Contract be declared illegal by a court of competent jurisdiction, or otherwise be determined or declared to

be void or invalid as a matter of law, then only that term, condition, clause or provision shall be stricken from this Contract and in all other respects this Contract shall be valid and continue in full force, effect and operation. The remaining terms, conditions, clauses and provisions shall remain in full force and effect for the duration of the Contract if not affected by the deleted term, condition, clause or provision.

4. **Statutory Reference.** All references to the Public School Code of 1949, as amended, contained herein shall also refer to any amendment or recodification of such Law.

5. **Choice of Law.** This Contract shall be construed in accordance with and governed by the laws of the Commonwealth of Pennsylvania. The paragraph headings used in this Agreement are included solely for convenience and shall not affect or be used in connection with the interpretation of this Agreement.


6. **Inurement.** This Contract shall be binding upon the parties hereto, their successors, assigns, administrators, executors and heirs.

7. **Entire Agreement.** This Agreement constitutes the entire understanding between the parties and supersedes all prior oral or written communications, proposals, representations, warranties, covenants, understandings or agreements between the parties relating to the subject matter of this Agreement.






