I. CALL TO ORDER

Mr. Foster, Chairman, called the Special Meeting to order at 5:20 P.M.

Mr. Ashcraft made a motion to go into a closed meeting to discuss specific student matters pursuant to the student exemptions of the VA Code §2.2-3711.A.2. Mr. Franklin seconded the motion.

The student is also encouraged to attend summer school based on final grades. Mr. Ashcraft seconded the motion.

Mr. Franklin made a motion that in Student School Placement to deny the request for attendance at L.L. Beazley Elementary School and approved student to attend North Elementary School. Mr. Ashcraft seconded the motion.
