### **APPLICATION FOR ABSENTEE BALLOT INSTRUCTIONS**

Education Law, Section 2018(a) states the rules and procedures school districts must follow in providing absentee ballots. The process is simple and is summarized below:

1. Applications for Absentee Ballots are available from the District Clerk.
2. You may download the application from the District's website: [www.tuckahoeschools.org](http://www.tuckahoeschools.org), call for one at (914) 337-6600 x1251 during the hours of 8:00 a.m. - 4:00 p.m., or write to:

3. **If you want the ballot mailed to you, the completed application must be returned by 4:00 p.m. on May 14, 2019, to the District Clerk.**
4. **If you want to personally pick up the ballot, the completed application must be received by the District Clerk no later than 4:00 p.m. on May 20, 2019.**
5. Please be advised that no person can have two legal residences for voting purposes.

It is not enough to own or lease a place of business in Tuckahoe. You must also qualify as a legal resident.
