## CAMPAIGN EXPENDITURE STATEMENTS TIMELINE 2018

AFFIDAVIT MUST BE FILED WITH THE DISTRICT CLERK AND THE COMMISSIONER OF  
EDUCATION AS FOLLOWS:

1. On or before the **30<sup>th</sup> day preceding** date of the election
2. On or before the **5<sup>th</sup> day preceding** the date of the election
3. Within **20 days following** the date of the election

**April 16, 2018:** Submission of first statement covering expenditures/contributions  
(Affidavit attached)

**May 10, 2018:** Submission of second statement covering expenditures/contributions  
(Affidavit attached)

**June 5, 2018:** Submission of final statement covering expenditures/contributions (Affidavit  
attached)

**If expenditures incurred by the candidate and others on his/her behalf total less than \$500, the candidate MUST file a sworn statement that his/her election expenditures did not exceed \$500.**
