

**ISLAND PARK UNION FREE SCHOOL DISTRICT**  
**SCHOOL BUS RULES AND REGULATIONS – High School Students**

1. The bus driver is in charge of the school bus and all passengers.
2. Failure to comply with instructions of the driver may result in student loss of bus privileges.
3. In order to protect the health and safety of all students:
  - a. Students must remain seated at all times when the bus is in motion.
  - b. Students shall conduct themselves in a quiet and orderly manner during the route.
  - c. Students shall not open bus windows without driver’s permission.
  - d. Students shall not extend any portion of their bodies outside of the bus.
  - e. No objects of any kind shall be thrown from a school bus.
  - f. Eating and drinking is strictly prohibited.
  - g. Smoking, vaping, including use or possession of Juuls or any Juul-like apparatus, or using illicit substances is strictly prohibited.
  - h. Fighting, profanity and /or abusive language is prohibited.
  - i. Students must identify themselves when requested by the driver, school authorities and/or law enforcement agencies.
  - j. Students in all grades must produce their bus pass when boarding buses.
  - k. Damaging/defacing the bus is prohibited. Student/Parent will be held responsible for repair costs. (Penalty could include of up to five (5) school days)
4. The Principal and/or designee shall be responsible for enforcing all Rules and Regulations as the school bus is an extension of the school day.
5. The Principal shall advise parents of Island Park students who have lost bus privileges by telephone and confirm same in writing.
6. Lost bus passes will be replaced only after payment of one dollar (\$1.00) fee at the Transportation Office of the Island Park School District.

**PENALTIES FOR FAILURE TO OBEY RULES AND REGULATIONS:**

***May include one, a combination, or all of the listed penalties***

- Verbal or written warning
- Notification to parents
- Disciplinary probation
- Reprimand, restitution

Suspension from transportation and/or from school

*Parents/guardians are responsible for transportation when bus privileges have been suspended*
