

Nanuet Union Free School District BYOD Procedures

Nanuet Union Free School District is offering the opportunity for all Students and Staff to participate in a BYOD (Bring Your Own Device) program. BYOD users will have the ability to use their own Internet capable devices (e.g. tablet, phone, Chromebook, eReader, etc.) in the school buildings in order to facilitate the learning process. Participation in this opportunity is completely voluntary.

BYOD users are permitted to use the district's wireless network for legitimate educational purposes. Personal use of district wireless network is prohibited. In addition, if a particular behavior or activity is generally prohibited by law, by Board of Education policy, or by school rules or regulations, use of the Nanuet Union Free School District wireless network for the purpose of carrying out such behavior or activity is prohibited.

The use of the Nanuet Union Free School District wireless network must be used in accordance with the following guidelines and support the educational goals of the District

Devices and the Network:

1. Classroom use of devices by students is up to the discretion of the teacher.
2. All devices must be charged prior to the start of the school day; charging devices will not be permitted in the school buildings.
3. There will be no printing from personal devices.
4. Connecting personal devices to district hardware is prohibited.
5. Connecting devices physically to the network (using a wire) is prohibited.
6. BYOD users will experience the student level filter restrictions currently in place on the network.
7. The Nanuet Union Free School District is not responsible for the BYOD user's personal device. This includes but is not limited to: lost, stolen, or malfunctioning equipment; devices should be transported and/or locked in a secure location when not in use.
8. Technology support will not be provided for any software or hardware device that the BYOD user brings to the school district.
9. The Nanuet Union Free School District will not be responsible for any malfunction of the BYOD user's device due to any changes made to the device.

10. BYOD users will not be allowed to make any additions or alteration to, or deletions from equipment that will result in a degradation or disruption of District equipment or performance of the District's wireless network.

The BYOD User Must:

1. Use the Nanuet Union Free School District wireless network for educational purposes only.
2. Understand that unauthorized use may lead to disciplinary action.
3. Understand that electronic communication should not be considered to be secure or private.
4. Understand that computer activities may be monitored and tracked on personal devices.
5. Understand that while BYOD users are permitted to use such devices, they are prohibited from using them in any manner which invades the privacy of students, employees, volunteers, and visitors.
6. Understand that personal devices are brought to school at the students' and parents' own risk. The District assumes no responsibility for personal devices. Students assume all responsibility for securing personal devices.
7. Understand that BYOD users are responsible for their own mobile network connections and for the costs associated with use of such devices.
8. Understand that personal devices may not be used to record, transmit, or publish images or video recorded at school without a teacher's permission and the permission of all students, teachers, and staff in the photo or video.
9. Understand that the District reserves the right to inspect a personal device should there be reason to believe that a user has violated the District's Acceptable Use Policy, Code of Conduct, or the Dignity for All Student Act (DASA anti-bullying law).
