INSTRUCTIONS:

Applications for absentee ballots must be received by the District Clerk of the Carmel Central School District at least seven days before the vote if the ballot is to be mailed to the voter by the school district, or by the day before the vote, if the ballot is to be delivered personally to the voter. These regulations are according to New York State Education Law, Section 2018-a.

An absentee ballot must be received at the Carmel Central School District, 81 South St., P.O. Box 296, Patterson, NY 12563 by 5 PM, on the day of the vote in order to be valid.
