Private and Parochial Schools Request for Transportation School Year 2020-2021

Eligibility: Kindergarten children who are 5 on or before December 31st, and children in Grades K-8 who reside 2 – 15 miles from the school, they will be attending and 3 – 15 miles for students in Grades 9-12.

Per State Law, the District is not required to transport to Pre-School Programs or Other Public Schools

Instructions:

1. Complete a separate application for each child and for each school to which he/she applies
2. Completed applications must be submitted **ANNUALLY**
3. Completed and Signed applications must be received no later than 3:00 PM on APRIL 1, 2020
4. First time applicants must provide 3 proofs of residency as noted on page 2
5. Incomplete applications will be returned to the sender unconsidered

Busing information such as Pick up times and Locations will be mailed home in August. You will only be contacted if you do not qualify for transportation due to the mileage requirements.
