Full Payments are due without penalty by September 30, 2019. Post office postmarks are acceptable, postage meter postmarks are not. Full Payments with an additional 2% penalty included will be accepted from October 1, 2019 to November 5, 2019. All balances not received by November 5th are turned over to the County. The County will then bill you and an additional penalty will be added.

Installment Payments:

First Installment Payments are due by September 16, 2019.

Second Installment Payments will be billed and collected by the County at any time up to March 15, 2020.

FAQ

1. **How do I get a copy of my tax bill?**

You may visit www.infotaxonline.com to print a copy of your tax bill or receipt, choose Pawling from the list of municipalities, then in the search box for taxpayer enter last name only then click on search button.

2. **How do I get a copy of a paid receipt?**

Receipts are mailed to homeowners in November including those with escrow accounts. If you need a copy of a receipt, please visit www.infotaxonline.com and follow instructions above.

3. **What if my mortgage company pays my taxes?**

You can still use www.infotaxonline.com to verify payment, however, if your payment is not shown, you will need to direct your questions to your mortgage company or bank.

4. **How do I change the address where my bill is sent?**

5. **How do I enroll in the STAR program?**

To enroll in STAR, you will need to visit the NYS Department of Taxation and Finance's website at www.tax.ny.gov/star or you may call (518) 457-2036 between 8:30 AM and 4:30 PM on weekdays.

6. **When is the last day I can pay my school taxes?**

- A. First Installment Payments **must be postmarked** no later than September 16th.*
- B. Full Payments without Penalty **must be postmarked** no later than September 30th.*
- C. Full Payments with a 2% Penalty **must be postmarked** no later than November 5th.*

* Only Post Office postmarks will be accepted, no postage meters.
