

**I. CALL MEETING TO ORDER:**

A Berkeley Township Board of Education Regular Meeting was held on Tuesday, December 17, 2013, at the Berkeley Township Elementary School Auditorium, 10 Emory Avenue, Bayville, New Jersey. Board President, Jim Fulcomer, called the meeting to order at 6:30 p.m. Adequate notice of this Meeting was given in accordance with the provisions of the Open Public Meetings Act.

**II. FLAG SALUTE:**

The meeting was opened with a salute to the flag. Mr. Fulcomer asked for a moment of silence in memory of our brave warriors some of whom have died recently in Afghanistan. Steve Pellecchia lead everyone in prayer for those who died in Afghanistan.

**IV. PRESIDENT'S REPORT:**

Thank you, everyone, for coming to this meeting. We welcome your attendance, and we invite you to make suggestions, questions, and criticisms during the public portions of this meeting. Your input during the public portions of this meeting helps our Board of Education to do a better job.

The first message I have tonight is to wish everyone a Merry Christmas and Happy New Year—especially a Merry Christmas. Everyone is invited to partake of the refreshments in the hallway to help us celebrate this Christmas season, and if any refreshments are left over at the end of the meeting, feel free to take the leftovers home.

As educators, it is important to remember that Christmas is not only a religious celebration, but it also is a legal federal holiday. Christmas has been a legal federal holiday since 1870 when President Ulysses S. Grant signed a bill making it a national holiday in a signing ceremony on June 28, 1870. We may legally celebrate Christmas in our schools, but there have been efforts to suppress the celebration of Christmas. When I was a high school

teacher, I once had a principal who tried to outlaw Christmas celebrations, but I led an effort to restore the celebration of Christmas and the Board of Education wisely overruled that principal's attempt to suppress Christmas. Historically, Christmas celebrations on December 25<sup>th</sup> were outlawed in the 17<sup>th</sup> century in Puritan New England and in England by the Puritan parliament under the commonwealth regime of Oliver Cromwell. The Puritans found no evidence in the Christian Bible that Jesus was born in December and found evidence that Jesus actually was born in the Spring. One of the slogans supporting the restoration of the British monarchy was the cry from the people: "Give us our Christmas back!" We in the English-speaking world now have our Christmas back, and I hope we will continue to celebrate this Christmas season because it brings great happiness to all who cherish this celebration, especially our children.

We have many blessings in our school district. One is that we continue to have high test scores. Another is that we have the safest schools in our county. Every school has a principal, at least one supervisor, and a policeman on our 2014 payroll plus architectural configurations that foster student safety. Our Superintendent has received an award for student safety.

Our latest labor contract puts us in an increasingly competitive position to continue to attract the finest teachers in Ocean County. We will be appointing two new teachers, Bonnie Bednarz and Ashley Walder, to our faculty. We welcome them to our educational community.

There has been an increase in our total student enrollment since December 2012. As of November 2014, our largest regular class size is 26 students and our smallest regular class is 15 students. Compared to December of last year, the enrollment at the Bayville School is down from 447 to 415. It is up at the Clara B. Worth School from 606 to 624. The H.&M. Potter School enrollment went up from 463 to 502 and the Berkeley Township Elementary School enrollment went up from 531 to 568. Based on that fact that in November four 3<sup>rd</sup> grade classes had at least 26 students at CBW, I asked that the Superintendent investigate whether it would be prudent to hire an additional 4<sup>th</sup> grade teacher for the 2014-2015 academic year. Every study that I have read on student achievement indicates that overcrowded classes are detrimental to student success. It is important that we maintain reasonable class sizes for all students as part of our school program. The federal government through HUD is providing \$50,000 forgivable loans for affordable housing clients who move into Berkeley Township. Therefore, we may have a larger increase in student enrollment in 2014-2015 than was last predicted by our demographer.

One of the most important factors in having a successful school system is a good tax ratable base. To that end, we will be considering three resolutions which, if implemented by higher governmental authorities, would increase revenue for the funding of Berkeley Township schools and create a better climate for the expansion of our tax ratables. These resolutions concern the dunes at Island Beach State Park, the Fair School Funding Act, and the Homeowner Flood Insurance Affordability Act. The first resolution asks the Governor and state legislature to grant easements to the Army Corps of Engineers to build state-of-the-art dunes for the entire length of Island Beach State Park. During Superstorm Sandy, low points at Island Beach State Park acted like water cannons pointed at Good Luck Point in

Bayville and helped to raise the flood levels in Barnegat Bay. Army Corps of Engineers dunes at Island Beach State Park would lessen the damage caused by future super storms and create facts that would lessen the planned drastic increases in flood insurance policies. The second resolution directs our Board Secretary to send letters to other school boards that would benefit from the proposed Fair School Funding Act in the hope that they would help persuade their state legislators to move in the direction of the proposed Fair School Funding Act. If adopted, the Fair School Funding Act would be very beneficial to our school district. The third resolution urges the U.S. Congress and our New Jersey Congressional delegation to support the Homeowners Flood Insurance Affordability Act. This act would delay the planned drastic floor insurance increases under the Biggert-Waters Act and develop studies to analyze to what extent they eventually can be avoided. The present prospect of drastically increased flood insurance premiums already has begun to have a chilling impact on real estate values in the maritime areas of Berkeley Township. If these drastically increased flood insurance premiums are allowed to prevail, then it will be very unlikely that we will be able to restore our pre-Sandy tax ratables in time to start paying off our CDL loan.

## **VI. PUBLIC DISCUSSION ON AGENDA ITEMS:**

**KATHY FULCOMER, 356 Roberts Avenue, South Seaside Park:** I would urge you to support all three resolutions, and I did want to mention one thing about the Island Beach resolution. Since Berkeley is such a maritime area, I am sure that most of our students and staff were either personally affected by Superstorm Sandy or they have a friend or relative who was, and I want to make one point about the importance of dunes. Midway Beach—the little section of the little cottages at Midway Beach—didn't have a drop of water because they have dunes, and they are also classified for flood insurance as an "X." That means they don't have to have any flood insurance, and many of them are oceanfront homes, so dunes make a tremendous amount of difference, and I would urge you to vote "yes" on that.

I would also urge you to vote "yes" on the other resolution about the Biggert-Waters Act. To delay it would give more time for more study as to the accuracy of those maps. A lot of us that have been going to many city council meetings we have spoken about that quite frequently. The other thing too about the Biggert-Waters Act delay—it would give them more time to do an affordability study which is supposed to accompany the Act, so I would urge all of you to support all of those resolutions.

MOTION by Mr. Mooney that upon recommendation of the Business Administrator Items 8 – 10 be approved.

SECOND by Mr. Pellecchia.

ROLL CALL VOTE: (8 Ayes, 0 Nays, 1 Abstain – Ms. Ciccone-Zawada on Items 8, 9 and 10). Motion carries.

**8. Transportation Jointure End: ACTION**

Recommend the Board end the transportation jointure between Berkeley Township School District (Jointer District) and Central Regional School District (Host District) for the following students:

- I.D. #994801 – Jackson Regional Day School - eff. 11/27/13
- I.D. #994386 – Jackson Regional Day School - eff. 11/27/13

**9. Special Education Transportation Route: ACTION**

RESOLVED that the Berkeley Township Board of Education approve Special Education Transportation Route #29 to Jackson Regional Day.

**10. Transportation Jointure: ACTION**

Recommend the Board approve a transportation jointure between Berkeley Township (Host District) and Central Regional (Joiner District) to transport one student from Central Regional High School to Habitat for Humanity and one student from Central Regional High School to home at the per diem rate of \$87.00.

**X. OLD BUSINESS:**

None.

**XI. NEW BUSINESS:**

MOTION by Mr. Ferlise to adopt New Business Item 1.

SECOND by Ms. Ciccone-Zawada.

MR. FULCOMER: The motion is to ask the Army Corps of Engineers to build dunes on Island Beach State Park. A similar resolution was adopted by the Municipal Council and a letter was sent by the Mayor to the appropriate authorities. This merely takes the same position as the Mayor and the Municipal Council of Berkeley Township and other groups in the Barnegat Bay Watershed. Is there any further discussion on this motion?

MR. PELLECCIA: I would like to postpone this resolution at this time.

MOTION by Mr. Pellecchia to postpone New Business Item 1 until the next Board of Education Meeting.

SECOND by Mrs. Kowalewski.

MR. FULCOMER: Is there anyone who would like to discuss whether this should be postponed. I will hand the gavel over to the attorney. One of the reasons why neighborhoods have flooded in Berkeley Township is because of low points on the dunes. It is very important that as many resolutions as possible be adopted urging the Governor and the State Legislature to have Army Corps of Engineers standard dunes built at Island

Beach State Park to protect our citizens. This not only affects the victims, but it also will affect the senior communities, because if there is not a major improvement in the dunes system, there is no doubt that insurance rates are likely to skyrocket for flood insurance and this will have a negative impact on rates in the maritime areas and ultimately end up with substantial property tax increases in the senior communities, so if you want property taxes in the senior communities to go up, then I would suggest you vote for this. If you want people to suffer because dunes are not built, then I would suggest you vote for this postponement. Otherwise I would urge you to vote “no” for the good of the people of Berkeley Township.

MR. PELLECCIA: I didn't say it was not good for the community. I said that I believe that Council is taking care of this. We are a non-political organization, so if the Council is taking care of it and can get it done, then I think they should do it.

MR. FULCOMER: Is there any further discussion? A “yes” vote is to postpone; a “no” vote would allow us to vote on the resolution.

ROLL CALL VOTE: (5 Ayes, 3 Nays, 0 Abstains). Motion to postpone carries.

**1. Dunes at Island Beach State Park:**

**ACTION**

WHEREAS, low points in the deficient dunes at Island Beach State Park acted like water cannons pointed at Good Luck Point in Bayville, New Jersey, and helped to raise the flood levels that adversely affected the maritime areas of Berkeley Township and other municipalities on the Barnegat Bay basin during Superstorm Sandy; and

WHEREAS, the Army Corps of Engineers would build dunes that would do a much better job protecting the residents and vacationers in the Barnegat Bay watershed.

NOW, THEREFORE, BE IT RESOLVED, that the Berkeley Township Board of Education requests the Governor of New Jersey and the New Jersey State Legislature grant easements to the Army Corps of Engineers to build state-of-the-art dunes for the entire length of Island Beach State Park; and

BE IT FURTHER RESOLVED, that the Berkeley Township Board of Education directs our Board Secretary to send a letter, along with a copy of this resolution, to the Governor of the State of New Jersey, the State Senate President, the Speaker of the State General Assembly, all State legislators representing Ocean County districts, and State Senator Bob Smith; and

BE IT FURTHER RESOLVED, that the Berkeley Township Board of Education directs our Board Secretary to send a copy of this resolution to all Boards of Education representing constituents in municipalities with maritime areas in the Barnegat Bay Basin.

MOTION by Ms. Gingrich that New Business Item 2 be approved.

SECOND by Mr. Ferlise.

ROLL CALL VOTE: (8 Ayes, 0 Nays, 0 Abstains). Motion carries.

**2. Fair School Funding Act:**

**ACTION**

WHEREAS, the Berkeley Township Board of Education repeatedly has adopted resolutions endorsing the proposed Fair School Funding Act; and

WHEREAS, the adoption of similar resolutions by school boards that benefit from this proposed Act would be helpful in promoting its adoption.

NOW, THEREFORE, BE IT RESOLVED, that the Berkeley Township Board of Education direct our Board Secretary to send appropriate letters to other school boards that would benefit from this proposed Fair School Funding Act, along with copies of the last two resolutions we adopted on this issue.

MOTION by Mr. Ferlise that New Business Item 3 be approved.

SECOND: None.

Motion fails.

**3. Homeowner Flood Insurance Affordability Act:**

**ACTION**

WHEREAS, the Biggert-Waters Act is in the process of drastically increasing flood insurance rates in Berkeley Township and other affected areas;

WHEREAS, these drastic increases could have a very negative impact on the ratable base that supports public education in Berkeley Township and greatly hurt many residents in Berkeley Township; and

WHEREAS, the Homeowners Flood Insurance Affordability Act has been proposed in the U.S. Congress to delay the drastic flood insurance increases and develop studies to analyze to what extent they eventually can be avoided; and

WHEREAS, the adoption of the Homeowners Flood Insurance Affordability Act would be beneficial to the tax base of our Board of Education and our constituents.

NOW, THEREFORE, BE IT RESOLVED, that the Berkeley Township Board of Education urge the U.S. Congress to adopt the Homeowners Flood Insurance Affordability Act; and



BE IT FURTHER RESOLVED, that the Berkeley Township Board of Education direct the Board Secretary to send a letter to all members of the New Jersey Congressional Delegation urging them to support this legislation and to respond to our letter; and

BE IT FURTHER RESOLVED, that the Berkeley Township Board of Education directs the Board Secretary to send a copy of this resolution to the Mayor of Berkeley Township and governing body and to the Business Administrator of the Central Regional Board of Education.

**XII. PUBLIC DISCUSSION OF NON-AGENDA ITEMS:**

**KATHY FULCOMER:** I want to congratulate and wish well the two members who are leaving the board. I think that in America where we have such a wonderful spirit of volunteerism the Board of Education is one of the highest and most noble and helpful areas and even when my husband decided to run for the board, I said, "Oh my gosh, 42 years in a public high school and elementary. You know what you guys would be doing!" I think all of you from all walks of life, you are willing to give your time and your dedication and you are willing to learn, and I think it's a wonderful thing. I want to thank those two members and continue to thank the members who are presently seated here.

I would also like to say a word about the outgoing President of the Board of Education because this would be the last meeting that you are presiding over. Some of you may chuckle at this but I have watched the president, Mr. Fulcomer, preside over meetings for 49 years starting when I was 17 years old and a freshman at then Newark State, now Kean University, and I would like to say that he has always done it with expertise and made the public feel at ease, and I think he's always done wonderful job, as you all have, at conducting yourselves at these meetings. I wish you all a Merry Christmas and a wonderful New Year and look forward to January.
