Resolution Authorizing Changes to Terms and Conditions of Employment for: Special Education School Improvement Specialist RSE-TASC: Mrs. Glaser moved, seconded by Mr. DeSantis that the resolution as stated below and on Attachment XII be approved:

BE IT RESOLVED, that the Southern Westchester Board of Cooperative Educational Services. Sole Supervisory District of Westchester County, approves compensation changes for the Terms and Conditions of Employment for the above referenced employee groups at its Business Meeting held on June 20, 2018 for the period effective July 1, 2018 through June 30, 2019 as follows:

Resolution to Accept the Memorandum of Understanding: Mrs. Glaser moved, seconded by Mr. DeSantis that the Memorandum of Understanding as listed below and on <u>Attachment XIII</u> be approved.

WHEREAS, the BOCES Teachers' Association (the "Association") and the Southern Westchester BOCES (the "BOCES") engaged in negotiations for a successor agreement to the Collective Bargaining Agreement that expired on June 30, 2014; and

WHEREAS, the parties agreed to terms of a successor agreement (the "CBA"), which agreement was set forth in a Memorandum of Agreement ("MOA") dated October 26, 2017; and

WHEREAS, both the Association and the Board of Education of the BOCES has ratified the MOA; and

WHEREAS, four issues have been identified as in need of clarification to avoid future controversy over the intent of the parties to the MOA; and

WHEREAS, the Association and the BOCES determined that a memorandum of understanding ("MOU") would provide for such clarification by the parties;

NOW, THEREFORE, IT IS AGREED by and between the parties that the following is to supplement the MOA to provide the necessary clarification:

- 1. Delete Article XVI and renumber the rest of the Articles in the CBA.
- 2. Article XVIII(C)(3)(b) to the CBA shall state that a bargaining unit member must have 50 days or more of accumulated sick days upon the date of retirement to be eligible for compensation of credit towards the payment of health insurance in retirement.
- 3. Article XVIII(C) (3) (b) to the CBA shall include the following sentence: "If there exists a legitimate, extenuating circumstance that would not allow for the employee to provide the 120 day notice in advance of his/her retirement, the BOCES Deputy Superintendent or his/her designee may excuse such requirement, which decision shall not be subject to the grievance provision of this Agreement."
- 4. Article XIX (E) (6) to the CBA shall be interpreted so as to allow a unit member to move one lane every 24 months, regardless of the number of credits the unit member accumulates within that 24 month period. Additionally, it was the party's intent to not allow a unit member to jump over a lane if they accumulate sufficient credits to do so while awaiting the next opportunity for lane movement.
- 5. It is understood between the parties that the teacher aide3s, which are represented by the BTA under a separate Collective Bargaining Agreement, will enjoy the same \$5.00 per year increase to their summer school pay that the parties agreed to in the MOA.
- 6. This MOU is subject to ratification of the Board of Education of the BOCES, due to the fact it increases that rate of pay for the teacher aides for summer school.

• Stacey DePaulo, Teacher at Irvington is here this evening and I would like to thank her and all of our teachers for all of her hard work and to let the Board know that 97 and 89 students have "reached mastery" in different programs.

COMMENTS FROM MEMBERS OF THE BOARD AND STAFF

Mrs. Frazer-McBride thanked everyone for reaching out to her and her family on the passing of her Mom.

Ms. Doherty informed the Board that everything is in place for summer school and that all the teachers are very excited and positive to begin.

Mrs. Riedel informed the Board, that like usual, the graduations and events have been once again very well planned and a wonderful tribute to our students. The graduation at the Decagon was my favorite as the Board of Education members stood and shook hands with the graduates. There were 100 students and 70 students also received their citizenship.

Ms. Murphy informed the Board that over the last 2 years Adult and Community has received 3 grants over the next 5 years totaling \$4.225 million.

Mr. DeSantis informed the Board that the Nominating Committee, with the agreement of the two candidates, will at the Reorganization Meeting, nominate Catherine Draper for President and John V. Filiberti as Vice President.
