However, the cells have not been protected so users may also enter the information manually. To bring forward amounts automatically, the most recently revised FY 2013 budget must be saved as budget13.xls in the C:\CSFORMS folder. If the file is not named budget13.xls, the formulas will not function properly. Excel will ask the user to update information when the budget14.xls file is opened.
