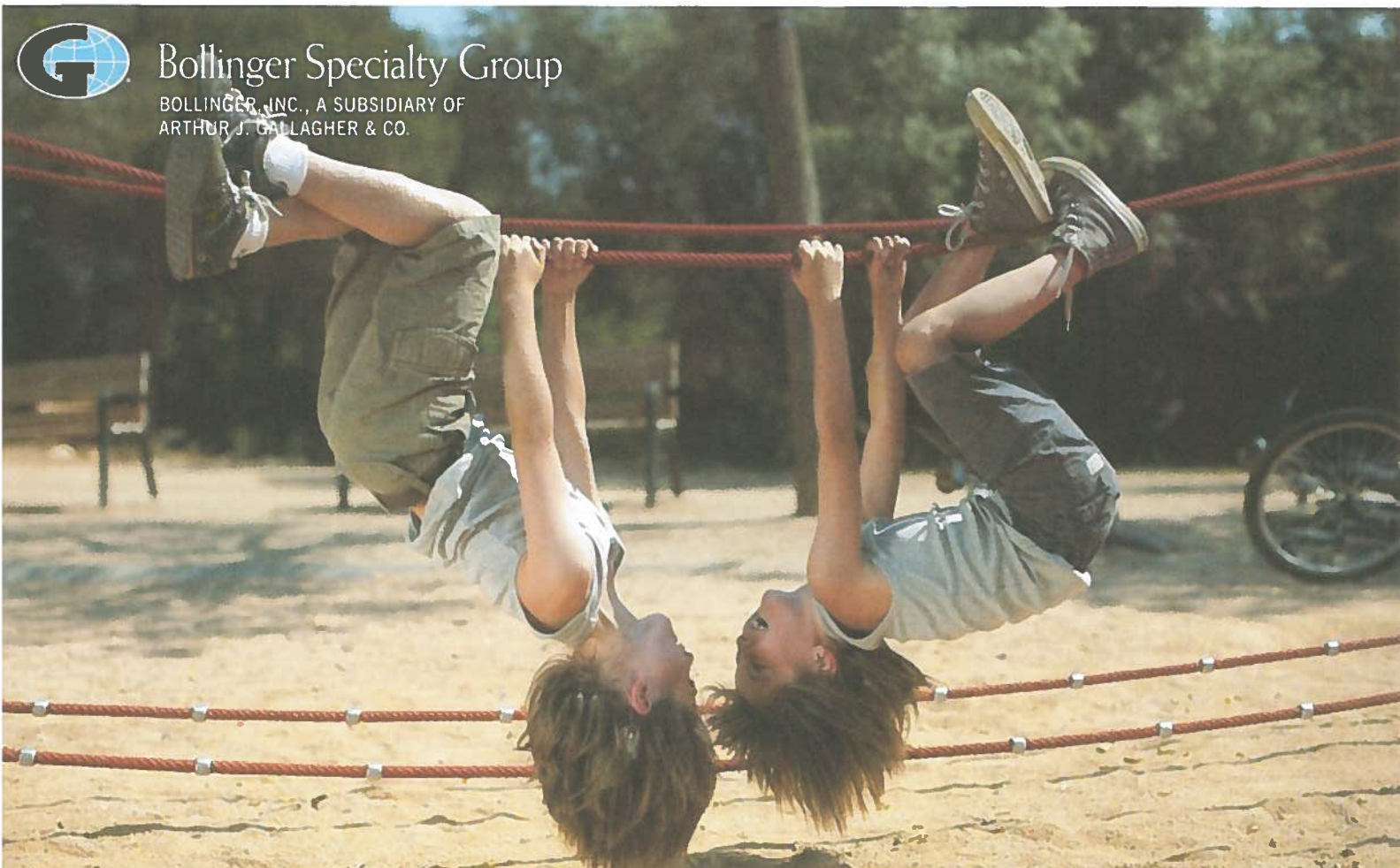

### STUDENT ACCIDENT INSURANCE

Enclosed you will find a sample of the flyer available for your district's student accident insurance plan for the upcoming school year.

The flyer directs parents to our website where voluntary student accident insurance may be purchased online or they may print the application to mail back to our office. *Bollinger is no longer printing brochures for distribution.*

The flyer is available to download from our website [www.BollingerSchools.com](http://www.BollingerSchools.com). In the section labeled "School Officials Only", click on the Voluntary Flyer link. From this link you will be able to print additional flyers for distribution. However, we suggest that you attach the flyer to your school's website and/or parent portal. By eliminating distribution, this method will save your administrative staff valuable time.

#### PLEASE NOTE:

1. The brochure containing a full description of benefits is available to parents on our website.
2. Bollinger Specialty Group will provide a name list of students who have purchased coverage to the Business Office. The list should be distributed to each school so that coverage can be verified prior to submitting a claim.
3. Parents should NOT return completed enrollment forms to the school. All forms should be mailed by parents directly to Bollinger Specialty Group, PO Box 1515, Morristown, NJ 07962. Applications received by Bollinger by September 30<sup>th</sup> will be effective retroactive to the first day of school. Any applications received after September 30<sup>th</sup> will be effective on the date they are received by Bollinger.
