- **Thursday, May 7, 2020, 6:00 PM – Special Meeting**
 - To discuss the Superintendent’s Preliminary 2020-2021 Annual School Budget;
 - This meeting was announced by Board President Amy Moselhi at the Regular Meeting on May 5, 2020, held in public.
- **Monday, May 11, 2020, 7:00 PM – Special Meeting**
 - The Board anticipates voting on a resolution to approve the Proposed 2020-2021 Annual School Budget and authorize its submission to the voters at the Annual District Meeting, June 9, 2020. The Board may consider voting on any other time-sensitive resolutions pertaining to the Annual District Meeting on June 9, 2020.
- **Tuesday, May 19, 2020, 7:00 PM – Committee of the Whole Session**
 - NOTE: This meeting was previously scheduled to be held on Wednesday, May 20, 2020, 7:45 PM; however, since the May 19th Election/Vote was recently postponed by the Governor, the C.O.W. Session may now be held on Tuesday, May 19th.
- **Thursday, May 28, 2020, 7:00 PM – Public Hearing on the Proposed 2020-2021 Annual School Budget**
 - Public comment will be held only on the topic pertaining to the Proposed 2020-2021 Annual School Budget. The time allotted for each speaker will depend on the total number of speakers.
