NYS Charter School Annual Report Due August 3, 2020

All New York State charter schools are required by law to submit an annual report to the Board of Regents and their authorizer by August 1st of each year through the NYSED Charter School Office's (CSO) online portal: https://nysed-cso.smapply.io/prog/2019-2020_annual_reports/.

Since August 1st falls on a Saturday this year, the annual reports are due by 11:59 pm on August 3rd, 2020. Please note, the portal is now open for schools to work on and submit their report.

Any school or Charter school in Good Standing that has a Level 1 for any subgroup will have to participate in a needs assessment ‘survey’ as part of their Consolidated grant application

The survey is titled, “2020-21 Consolidated Application - Level 1 Addendum”

Districts, with schools designated as ‘PRIP’, must complete a plan, have it approved and signed by the BOE and post on the district website.

Expected Grades with Enrollment 2020-21 Application Due Sept. 11, 2020

The Expected Grades with Enrollment form collects information about the grade levels a school will be reporting enrollment for on BEDS day for the 2020-21 school year. The purpose of the collection is to improve state-wide data quality for both state and federal reporting. Please complete the form as grades in your buildings would normally be configured and not according to your school reopening plan in response to COVID-19.

All public-school districts (outside of New York city) and all charter schools are required to submit the Expected Grades with Enrollment Form online using the IRS Data Exchange application, available via the NYSED Business Portal at <http://portal.nysed.gov>.

The online form should be completed and submitted to SED by Friday, September 11, 2020.
