Introduction

The PD Data System is NYSED's online tool for the collection, verification, and certification of Special Education Data. The data is presented through Verification Reports (VR) and PD forms (PD). Most of the data displayed in the PD system is pulled from the SIRS data warehouse; however, the data for some PD forms is entered directly into the PD Data System. The data comes from your Special Education System and some data comes from your Student Management System.

There are two PD certification periods which occur every school year. These reporting periods indicate who is receiving services at a specific time. The **BEDS Day Snapshot** is certified in January for VR's 1-9 reports for any student that is receiving services on BEDS day. **End of Year Reporting Certification** has two deadlines associated with it. **In August, an End of Year Snapshot** is reported for preschoolers who received services at any time during the year. In addition, districts who set aside 15% of their IDEA funds for Coordinated Early Intervening (CEIS) services must report on those students who may have benefitted from those services. Depending on a district's federal indicator submission schedule, COSF (Child Outcome Summary Form) Assessments are also reported. In September, the **SE Events, reports of a district's compliance with timeliness of evaluations**, are due. See the End of Year Reports section of this document for more information.

The only data that can be reported directly into the PD Data System are the PD 6 (Personnel Form) typically due in February and PD 8 (Suspension Data) typically due in August.

Once data has been certified in the PD system, the data is frozen and will not update from SIRS anymore.

BEDS Day Snapshot

The data templates used for the reporting of VR's 1-9 are Demographics and Enrollment (sourced from your SIS), Program Service (Disability Type), and the Special Education BEDS Day Snapshot (sourced from Frontline IEP). The data from these templates are loaded to Level 0, and the data populates through the SIRS system into the PD site in the form of the VR reports. All reports should be reviewed before certifying.

For the **January Certification**, the related PD reports are as follows:

VR1: Preschool Child Count Report by Race/Ethnicity

VR2: School Age Child Count by Age and Disability

VR3: School Age Students by Disability and Race/Ethnicity

VR4: Preschool LRE Setting Report

VR5: School Age LRE Setting Report

VR6: District Report of Preschool Students by Primary Service Provider

VR8: District Report of School Age Students by Building Where Enrolled

Note: VR 7 and 9 are provider reports that do not require certification but require review.

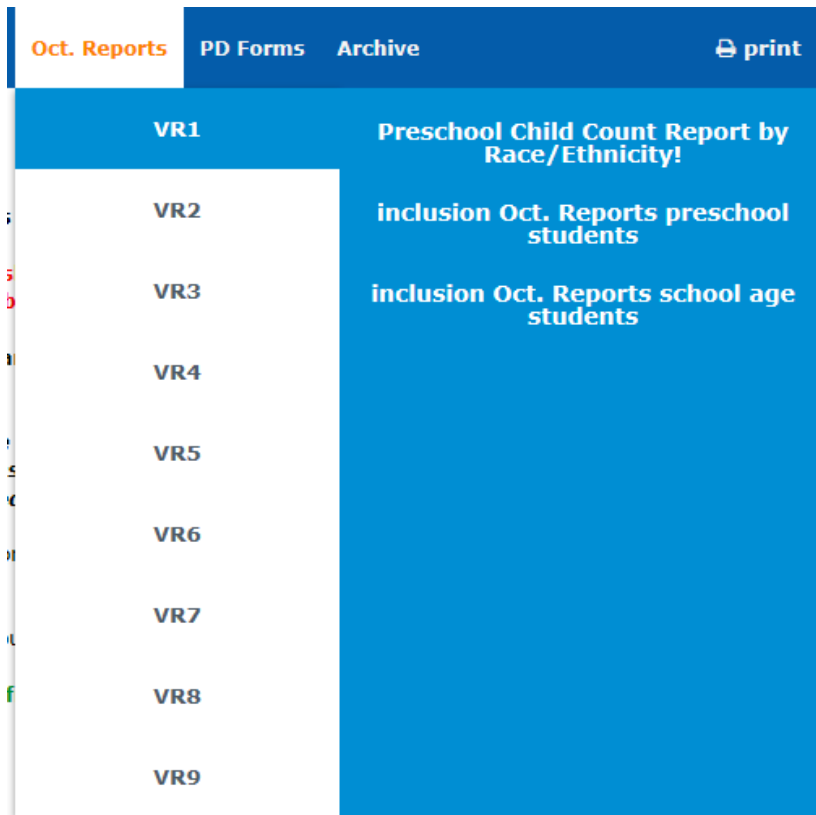

End of Year Reports

There are various Special Education Verification Reports (VR's) and Federal Indicators that are certified at the end of the year and public schools are assigned each year which indicators they are required to certify. Such reports are the VR's 11, 12, 13, 14, 15, & 16 and their related Federal Indicators 11, 12, and 7. The SIRS data templates used for the EOY Reporting are Demographics and Enrollment (sourced from your SIS), Program Service (Disability Type), Special Education COSF Assessment, Special Education Events and the Special Education End of Year Snapshot (sourced from Frontline IEP).

At EOY, there is other data required for submissions that is entered directly into the PD System. For public schools, these submissions include Indicators 8, 13, and 14, as assigned according to the SPP reporting schedule. In addition, all public and charter schools are required to enter data for the PD 8 (Report of Suspension Data of Students with Disabilities). Since this data does not populate through SIRS, and instead is entered directly into the PD Data system, the Special Ed department enters the data by the deadlines.

Public school districts who were identified for disproportionality, are required to allocate 15% of IDEA funds for CEIS activities.

VR 14: District Report of Parentally Placed Students in a Nonpublic School who were evaluated – All Public Schools must report

PD 8: Suspension Data of Students with Disabilities

****PD8 Report can be electronically imported through the Frontline IEP Direct system. If using the electronic import from IEP direct, then the race/ethnicity data from IEP Direct will be used and not what is reported in SIRS**

Indicators 8, 13, 14: These are surveys and self-reporting Indicators are assigned according to the SPP Federal Indicator Reporting Schedule.
