**Scholarship to be awarded:**

**Criteria for Application:**

1. Applicant must be a high school senior residing in Westchester County.
2. Applicant must submit their most recent transcript.
3. Applicant must be planning a major in accounting, and/or have applied (or be in the process of applying) to an accredited college or university, with a planned major in accounting.
4. Applicant must submit one letter of recommendation. The letter must be from a teacher, coach, or employer and cannot be from family or friends.
5. Applicant must submit a short essay (500 words or less) that is typed. The essay should include your career goals, the importance of a college education and an accounting degree in achieving those goals and why applicant believes he/she is deserving of the scholarship (e.g. academic, community, financial reasons, etc.).

**Application and documents must be received by Friday, April 27, 2018. Incomplete applications or applications received after the due date will not be considered.**

Additional requirements for winning applicants:

1.
