## Early Literacy Plan 2020-2021

Pursuant to W.S. 21-3-401, school districts are required to implement a reading screening program that includes a reading assessment plan for kindergarten through third grade. Schools not meeting proficiency are required to submit an Intervention Plan to be included in the School's Improvement Plan.

All students in grades K-3 who do not score proficient in reading in the fall are placed on either an Individualized Reading Plan (IRP) or a Group Reading Plan (GRP) and must receive supplemental/intervention reading instruction using an evidence-based intervention plan. IRPs and GRPs are required to be placed on file with the district.
