*The primary purpose of the Business Honor Society (BHS) of New York State is to recognize those students who have demonstrated outstanding achievement in a secondary business/marketing program.*

### **Eligibility**

- **Ceremony available only to current Seniors:**
  - Students must complete (or have completed) 4 business education courses (including at least 1 college level) in business education by the end of the fall semester of the current school year.

### **Minimum Criteria**

- GPA Business/Marketing Courses      88%
- GPA Overall                                      85%

Students selected for recognition will have also demonstrated both in the classroom and through extracurricular involvement:
