

Regular Meeting October 17, 2016

The Leggett Independent School District Board of Trustees met in regular session on Monday, October 17, 2016 at 7:00 P.M. with the following members present: Curtis Jefferson, Robert Nowlin, Vicki Russell, Kevin Puckett, Karen Pollard and Tommy Johnson. Member absent: Tommie Collins. Administrator present: Jana Lowe. Guest present: None.

The meeting was called to order by Curtis Jefferson.

The certification of public notice and the minutes for the regular meeting on September 19, 2106 were approved on a motion made by Kevin Puckett. Robert Nowlin offered a second. All members voting for the motion.

There was no citizen participation.

In communications and reports, Ms. Lowe reported our enrollment being at 160 students. It has slightly risen in comparison since 2015. She also reported that the PSAT test will be administered to eligible students on October 19, 2016. We will have our Red Ribbon Week (Drug Free) beginning on October 26, 2016, with activities planned for each day of the week. There are several fine arts activities planned, including High School Students attending Angelina College Fine Arts Review and Renn. Festival, Elementary students attending a concert at Livingston ISD. Leggett chose a nine weeks layout instead of six weeks for the calendar year. It has reduced testing stress and allowed more teaching time in classroom. Kevin Puckett did not seek re-election on the board and his term was concluded on October 17, 2016. He is a lifelong residence of the community and has served on the board since 2005. Leggett ISD wishes to express its thanks for the service of Kevin Puckett and of all past and presence board members.

In finance, Ms. Lowe discussed the delinquent tax report as well as the financial budget analysis report and the Lone Star Investment Pool with the Board.
