Parent and Family Engagement Plan**

***"Parent and Family Engagement" means the participation of parents in regular, two-way, and meaningful communication involving student academic learning and other school activities***

**GOAL:** To enhance the instructional program and academic achievement of students at South Larose Elementary School by involving parents in all aspects of the school's activities.

**OBJECTIVE:** The administration, faculty, and staff will provide a variety of programs to promote parent and family engagement to improve the academic performance of students. Documentation of these programs will include sign-in sheets, copies of the monthly school calendar, and school visitations.

South Larose Elementary will adhere to the following ESSA Parent and Family Engagement Federal Program Assurances outlined in Section 1116 of the Every Student Succeeds Act

**Part II: Six Types of Parent & Family Engagement:**

South Larose Elementary will utilize the Six Keys to Successful Partnerships to foster Parent and Family Engagement

**Standard I:**

***Parent: Parenting Skills are promoted and supported. South Larose Elementary will:***

- Purchase parenting books, magazines, and other informative material regarding responsible parenting
- Advertise current selections, and give parents the opportunity to borrow the materials for review.
- A Parent Center has been developed for parents and families and includes a lending library with materials of interest to parents of pre-adolescent children. Brochures and books that focus on parenting are available for loan through the Parent Center.
- Reading selections from the Parent Center are regularly highlighted in school newsletters to increase parent awareness of the available resources.
- The Parent Center also includes information regarding available community non-profit and private referral sources. This information is disseminated to families as needed.
- The Parent Center houses a designated parent computer.

## Standard II:

***Communication: Communication between home and school is regular, two-way, and meaningful.***

1. The Parent and Family Engagement Program at South Larose Elementary , developed by staff and parents, includes program practices that enhance parent and family engagement and reflects the specific needs of South Larose Elementary students and their families.
2. The Parent and Family Engagement Plan is comprehensive, coordinated and inclusive. Parent and Family Engagement roles are varied.
3. Communication between home and school is regular, two-way and meaningful. To encourage communication with parents, South Larose Elementary will:

**Prepare and distribute information packets to each South Larose Elementary family describing:**

- South Larose Elementary Parent and Family Engagement Plan/Program
- The various ways parents can volunteer at South Larose Elementary
- Planned parent and family engagement opportunities
- Parent communication methods
- The role of parents, teachers, and students. This information will be sent home in communication folders
- Parent volunteer and interest surveys

## **Two-Way, Meaningful Communication Methods:**

- Weekly communication folders are sent home to parents containing student work for parent comment and review along with other school information.
- The Parent Internet Website provides instant access for parents to view their student's grades, attendance, lunch account information and access tutorial help on the district's web-site:
- PTC, in conjunction with South Larose Elementary, publishes a monthly calendar to keep parents informed of upcoming events and other school issues. The calendars are sent home monthly in folders and also available to read on the school's web-page.
- Parents are encouraged to sign up for emails or Remind. Teams communicate with parents daily via e-mail/Remind app regarding homework assignments, upcoming projects and parent involvement events.
- Staff member's e-mail addresses can be accessed through school web-page.
- Parents without internet access are encouraged to use a computer designated for their use in the Parent Center.

## **Standard III:**

***Volunteering: Parents are welcome in the school and their support and assistance are encouraged.***

South Larose Elementary promotes and encourages a welcoming atmosphere to foster parent involvement and volunteer participation.

- South Larose Elementary does not have policies that hinder parent involvement at school.
- The Parent and Family Engagement Contact Person at the school encourage staff members to utilize the volunteer resource book published by PTC, which lists the interests and availability of volunteers.
- The information on the parent survey determines the frequency of each parent's desired participation, and includes the option of volunteering just one time per year, performing the work at home.

- The Parent and Family Engagement Contact person ensures that parent participation is acknowledged.
- Volunteers are encouraged to attend a training session held at the beginning of each school year.

**Standard IV:**

***Student Learning: Parents play an integral role in assisting student learning.***

In order to promote parents' efforts at South Larose Elementary Parent and Family Engagement meetings are regularly schedules and parents are provided up-dates/ reports on school business and an overview of:

- What student will be learning
- How students will be assessed
- What parents should expect for their child's education
- How parents can assist and make a difference in their children's education

**South Larose Elementary schedules regular Parent and Family Engagement meetings, such as:**

- Meet the Teacher
- Open House
- Dads on Campus
- Kidbiz Day
- Smarty Ants Day
- STEM Day
- Grandparents Day

At these meetings, parents receive a report of the state of the school, building test results, curriculum expectations and standards, how students are assessed, and information regarding how they can help children achieve academically.

## Standard V:

*School Decision Making and Advocacy: Parents are full partners in the decisions that affect children and families.*

South Larose Elementary includes the process for resolving parental concerns which is described in various newsletters, found in the Parenting Center, during the school year. The process includes:

- How to define a problem
- Whom to approach first
- How to develop solutions

## Standard VI:

*Collaborating with Community: Community resources are used to strengthen schools, families and student learning.*

Community resources strengthen school programs, family practices and student learning. To capitalize on community resources, South Larose Elementary:

- Encourages and supports the Bullpup Club, which fosters parental and community involvement at South Larose Elementary.
- Bullpup Club leaders' input is sought and utilized in appropriate decisions affecting students and families.
- Solicits community support and assistance with academic programming, extra curricula activities, fund raisers, and etc.
