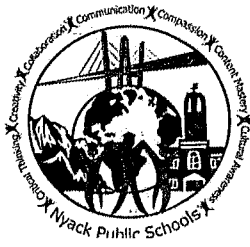
*Please note that although the performance is open to parents, there is limited parking at Nyack High School during the school day.*
