“Hold at Any Cost”: The Battle for Oak Ridge

The Battle of Gettysburg’s first day witnessed extensive combat, igniting an engagement that would persist in the memories of its veterans for decades to come. As fighting raged on McPherson’s Ridge to the west of town and on Barlow’s Knoll to the north, the Union defensive position along Oak Ridge proved to be a particularly important one as the battle raged throughout the day, serving as the linchpin between the Federal I and XI Corps. We will examine the fighting in this sector of the battlefield in addition to the heroic acts and errors carried out by individuals in both armies.

The Seven Days Battles

By midsummer of 1862, the Union was achieving victory on most fronts of the war. However, seven days in late June and early July would temporarily turn the tide of the war in favor of the Confederacy. This climactic conclusion to Union General George B. McClellan’s lengthy Peninsula Campaign would inaugurate a new Confederate threat that would persist until the final days of the war: Robert E. Lee. Six consecutive engagements, known as the Seven Days Battles, allowed the Confederacy to reach the peak of its success and formed an aggressive reputation for the Army of Northern Virginia and its celebrated commander.
