## HEALTH EXAMINATIONS AND IMMUNIZATIONS

Students who enter the district schools for the first time shall have a medical examination conducted at the medical home of the student, and a full report sent to the school. If a student does not have a medical home, the district shall provide this examination at the school physician's office or other appropriately equipped facility. "Medical home" means a health care provider and that provider's practice site chosen by the student's parent/guardian for the provision of health care. As the school physician is also a health care provider, the parent/guardian may request that the school physician provide the medical examination.

FILE CODE: 5141.3

A Student shall be exempted from mandatory immunization if the parent/guardian objects to immunization in a written statement submitted to the principal, signed by the parent/guardian, explaining how the administration of immunizing agents conflicts with the Student's exercise of bona fide religious tenets or practices. General philosophical or moral objection to immunization shall not be sufficient for an exemption on religious grounds.

Every Student who enters the district schools for the first time shall present an immunization record as required by law. At the parent/guardian's request, these immunizations may be administered by the school physician.

In order to protect the health of the children and staff in district schools, all regulations of the state department of education, the state department of health and the local board of health shall be scrupulously observed, particularly those dealing with contagious/infectious diseases or conditions. Students seeking to enter school who have been identified as having a communicable/infectious disease or condition shall not be enrolled unless they qualify under the above agencies' rules pertaining to periods of incubation, communicability, quarantine and reporting.

The Superintendent or his/her designee shall formulate regulations that ensure immunization records are reviewed and updated annually pursuant to N.J.A.C. 8:57-4.1 through 4.16. The Superintendent shall also formulate regulations for this policy and for regular Student health examinations at appropriate grade levels; before participation in sports programs; and for tuberculosis, scoliosis, hearing loss, visual acuity and any other physical examinations required by law. Any health defects revealed by any examination given by the school health services must be reported to the parent/guardian. The board shall review the regulations and adopt those required by law.

### HEALTH EXAMINATIONS AND IMMUNIZATIONS

### Mandated:

N.J.A.C. 6A:16-1.4(a)1 through –21 directs the board to develop policies and programs on various aspects of health examinations.

<u>N.J.A.C.</u> 6A:16-1.4(a)4 requires that schools develop and adopt written policies, procedures, mechanisms or programs governing the provision of health services including immunization, administration of medication, treatment of asthma, medical examinations, nursing services and emergency medical situations as required by N.J.A.C. 6A:16-2.

<u>N.J.A.C.</u> 6A:16-4.1 requires policy on assessment, intervention, referral for evaluation, referral for treatment and discipline of students whose use of alcohol or other drugs has affected school performance. Examination by a physician is included.

No Child Left Behind requires districts that receive federal funds to adopt policies on the administration of any physical examinations or screenings conducted by the board. Other NCLB required policy topics under amendments to the Protection of Pupil Rights law are addressed in file code 6162.5 Research.

## Other Reasons:

N.J.A.C. 6A:16-2.2(a) requires each school district to ensure that immunization records are reviewed and updated annually pursuant to N.J.A.C. 8:57-4.1 through 4.16.

N.J.A.C. 6A:16-2.2(c) requires tuberculosis tests on students based upon the incidence of tuberculosis or reactor rates in specific communities or population groups.

N.J.A.C. 6A:16-2.2(f) requires student medical exams be conducted at the "medical home" of the student or by the school physician.

<u>N.J.A.C.</u> 6A:16-2.2(h) describes the circumstances for required student medical examinations – entry into school, pursuant to a comprehensive child study team evaluation, and when applying for working papers.

N.J.A.C. 6A:16-2.2(h)1 requires the examination of any candidate for a school athletic squad to be conducted within 365 days prior to the first practice session and lists the components of that examination.

N.J.A.C. 6A:16-2.2(h)1, ii, (2), lists the components of the examination including abnormal curvature of the spine.

<u>N.J.A.C.</u> 6A:16-2.2(h)5 requires the examination of any student suspected of being under the influence of alcohol and controlled dangerous substances.

## HEALTH EXAMINATIONS AND IMMUNIZATIONS (continued)

N.J.A.C. 6A:16-2.3 describes required school medical personnel and sets out their responsibilities.

<u>N.J.A.C.</u> 6A:16-2.4(a) requires the board to maintain student health records to include the findings of health histories; medical examinations and health screenings pursuant to <u>N.J.A.C.</u> 6A:16-2.2 and 4.3; and documentation of immunizations against communicable diseases or exemption from those immunizations.

## **Recommendation:**

A policy directing compliance with law in all matters of examinations and immunizations. The examinations for determination of whether the pupil is under the influence of drugs/alcohol should be dealt with specifically at 5131.6.
