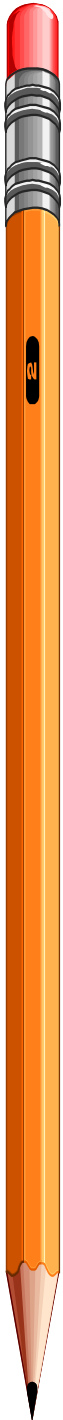
1. All trips have been cancelled until further notice.
