Further, on behalf of myself, my son/daughter/legal charge, and our personal representatives, assigns, heirs and next of kin, I HEREBY RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE the Penn-Trafford School District and the P-T High School, its officers, employees, agents or representatives for loss of damage and any claims or demands therefore on account of injury or death to my son/daughter/legal charge, where such injury or death occurs during, by reason of or arising out of this activity.
