The Special Public Meeting of the Board of Education of the Mount Pleasant Cottage School Union Free School District was called to order at 11:06 AM by Mrs. Rita Golden, President.

Business Matters: Mrs. Irwin moved that the Board of Education approve the Consent Agenda which includes items 3A and 3B.

- ◆ WHEREAS, in June of 2019, representatives of the District and the Mount Pleasant Cottage School Association of Teachers for the Custodial Staff, (the “Association”) executed a Memorandum of Agreement to create a three year successor Collectively Negotiated Agreement effective July 1, 2018 and terminating on June 30, 2021 to the one which expired on June 30, 2018; and

WHEREAS, the Association has ratified the Memorandum of Agreement and Board ratification and approval of the Memorandum of Agreement that created the parties’ 2018 to 2021 Collectively Negotiated Agreement is required; and

NOW, THEREFORE, BE IT RESOLVED, that the Board hereby ratifies and approves the June 2019 Memorandum of Agreement between the District and the Association and hereby appropriates those monies necessary to fund the parties’ 2018 - 2021 Collectively Negotiated Agreement.

- ◆ WHEREAS, in September 2018, the International Brotherhood of Electrical Workers (“IBEW”) filed a Petitioner for Certification seeking to represent all full and part-time teacher aides in the District; and

WHEREAS, after the IBEW was determined by the New York State Public Employment Relations Board (“PERB”) to be the duly designated bargaining representative of part-time and full time teacher aides in the District, in or about March 2019, PERB directed the parties to commence negotiations on their first Collectively Negotiated Agreement; and

WHEREAS, during the months of April, May and June 2019, the parties commenced and completed negotiations on a Collectively Negotiated Agreement covering the period July 1, 2019 through June 30, 2020; and

WHEREAS, on or about June 25, 2019, the IBEW ratified the parties July 1, 2019 through June 30, 2020, Collectively Negotiated Agreement and Board ratification and approval of the agreement is required; and

NOW, THEREFORE, BE IT RESOLVED, that the Board hereby ratifies and approves the July 1, 2019 through June 30, 2020, Collectively Negotiated Agreement between the District and the IBEW and hereby appropriates those monies necessary to fund the parties' 2019 - 2020 Collectively Negotiated Agreement
