First Practice permitted November 6, 2017

First Scrimmage permitted after 8 Practice days for Team - 6 days for Individual

First Game permitted after 10 Practice days for Team - 8 days for Individual

Last Date for Game Saturday, February 10, 2018

Minimum Number of Contests To be eligible for sectional, intersectional or state competition, a team must have completed in six (6) school scheduled contests which occurred on six (6) different dates during the season.

Team Sports: An individual is eligible for the team if he/she has been an eligible participant on a team in that sport in that school for a minimum of six (6) scheduled contests during the regular season. A student must be an eligible participant for a minimum of three (3) contests for Football.

Team/Individual and Individual Sports: An individual must also have represented their school in six (6) scheduled contests during the season to be eligible. These required contests must occur on six (6) different dates and must be conducted prior to the conclusion.

GENERAL SECTIONAL PROTEST PROCEDURE

Any coach lodging a protest will immediately notify the AD/Site Coordinator of the contest. The term immediately is clarified to mean, "Before the ball becomes alive following the dead ball which the protested decision was made."

For all sectional games, there will be a three-person Protest Committee composed of the AD/Site Coordinator, another official (the timekeeper), and a third designated person. Each coach should know which person the AD/Site Coordinator is before the game.

1. The protesting coach will get the attention of the officials and write the time of the protest in the book at the first dead ball situation.
2. The AD/Site Coordinator, opposing coach, and officials on the court shall be notified.
3. The three-person Committee will declare the protest on the spot, and the AD/Site Supervisor will notify all concerned of the decision.
4. Games proceed to a conclusion. One team must win.

CANCELLATION PROCEDURE

1. First Round Games

Since games are held in "home" school gyms, cancellations should be handled as for a regular season game.

2. Make-up day must be the following day. Home Athletic Directors are responsible for contacting traveling opponents and tournament headquarters.
3. Decisions to postpone a 7:00 p.m. game must be made no later than 3:00 p.m.
4. Decisions to postpone a Semi-Final or Final round game and beyond will be made by the Section Chairperson after consultation with the Section One office and facility administrators.

TOURNAMENT DRAW PROCEDURE

1. The Committee will meet on **Monday, February 12, 2018**, to determine pairings, sites and other details of the tournament.
2. Game results through **Saturday, February 10, 2018**, will be considered in determining seedings.
