Minimum Number of Contests To be eligible for sectional, intersectional or state competition, a team must have completed in six (6) school scheduled contests which occurred on six (6) different dates during the season.

Team Sports: An individual is eligible for the team if he/she has been an eligible participant on a team in that sport in that school for a minimum of six (6) scheduled contests during the regular season. For football, a student must be an eligible participant for a minimum of three (3) contests.

Team/Individual and Individual Sports: An individual must also have represented their school in six (6) scheduled contests during the season to be eligible. These required contests must occur on six (6) different dates and must be conducted prior to the conclusion. {NYSPHSAA Handbook, pg 104, #25 a}

Maximum # of Contests – 16.

Due Dates: 1. Petition emailed no later than Oct. 19, 2017 to Sue Hughes. List all games, even those not played yet.
2. Remaining scores called in before 6pm on Oct. 21, 2017 to Sue Hughes and BOCES.

PROTEST PROCEDURES

1. Any protest procedures already established by the rules governing the sport must be followed.
2. General Sectional protest procedures:
 - a) Any coach lodging a protest will immediately notify an official (preferably head official) of the contest.
 - b) Immediately following the game or meet, all officials and coaches involved must be notified.
 - c) All details of the protest must be put in writing immediately following the game or meet and before the game leaving the field.
 - d) All written protests must be turned over to any member of the Sectional Sports Committee. If no member of the Committee is present, the head official shall accept the protest and be responsible for getting it to someone on the Committee.
 - e) The Protest Committee will make the final decision on all protests. This Committee will consist of all members of the Sectional Sports Committee, at least one neutral official, and any other members deemed necessary by the Sports Chairperson. League representatives of the schools involved will not vote on the decision.
 - f) The coaches involved will be informed of the Committee's decision as soon as possible.
 - g) The Chairperson and a neutral official will determine if a situation may be protested.
3. Specific Field Hockey Procedures:
 - a) A protest **cannot** be made regarding a judgment call.
 - b) Protests can only be filed for a misapplication of the rules.
 - c) A protest must be made immediately following the alleged misapplication and has to be announced to officials **prior to the next play**.
 - d) The Head Coach, not an assistant, must inform a filed official or table official of their intent to protest prior to the next play.
 - e) The Official Federation Rules for School Girls Guide states that "the Rules Committee does not make decisions on protests of games by leagues. Problems arising during a game should be solved immediately on the field, and coaches, when they hire officials, agree to abide by their decisions".

PROTEST AND APPEALS

Any and all questions and / or protest as to game rules and the conduct of the games shall be heard and resolved by the Games Committee. All decisions shall be final with no right of appeal. Each coach should have a Tournament Handbook. If you do not, please get one from your Section Coordinator.

For Semi and Final games; the Games Committee shall be made up of three Section Coordinators from neutral sections.

Any appeal of the State Handbook sportsmanship standard at the regional level shall be referred to the State Office for a decision.

Should the appeal occur at the championship games, a member of the NYSPHSAA staff or, in their absence, the State Coordinator will resolve the appeal.

SECTIONAL FINALS PROTEST PROCEDURE

Any and all questions and/or protest as to game rules and the conducts of the games shall be resolved by the Games Committee (Section Coordinator, Field Marshall and neutral official).

All decisions shall be final with no right of appeal. Each coach should have a Tournament Handbook and current rule book on site.

REGIONAL PROTEST PROCEDURE WHEN HOSTED BY SECTION ONE

Same procedure as above but the Games Committee with be (Section Coordinators from each section and neutral official)

Field Hockey Overtime Procedures 2017

- I. At the end of the regulation game, there will be a coaching intermission that will last up to 5 minutes. The Officials will:
- Meet with Captains and Coach.
 - Toss of coin: the home team calls the toss. The winner of the toss gets choice of possession OR end of field.
 - The tableside official remains the head official for all segments of the overtime procedures.
- II. Ten minute OT 7 V 7 sudden victory OT period:
- Rolling substitutions are permitted.
 - Each team is permitted one time out during the 10-minute overtime period
 - Defensive corners during 7 v 7:
 - Defense will be reduced to 4 players (3 plus goalie) behind end line
 - The remaining defensive player goes behind the 50 yd. line with the rest of the team.
 - The attack remains the same.
- III. If a tie still exists after the first 10 minute overtime, the teams will play a second 10 minute overtime.
- 7 V 7 Sudden Victory overtime period.
 - A coaching intermission, lasting 5 minutes, will be allowed prior to the start of the second OT period.
 - Teams will change ends of the field, the team not having possession at the start of the first OT shall have possession to start the second OT.
 - Time-outs may not be carried over from the previous period, each team is allowed one time out.
 - Rolling substitution are permitted.
 - Defensive corners same as above.
 - The attack remains the same.
- IV. If the score remains tied at the end of the second 10 minute overtime period; a Shoot-out will take place.

“NO SUDDEN VICTORY” shoot-out process. A set of 5 alternating shoot outs take place in each series.

- Players from each team take a one-on-one shoot-out alternately against the goalkeeper of the other team making a total of 10 shoot-outs.
- Five (5) players per team will take the shoot-out in the sequence nominated and communicated by the team to the umpires on duty before the start of the shoot-out competition. The order of shoot-out must be indicated to the umpires at the coin toss.

Field Hockey Overtime Procedures (cont.)

- The umpires, in conjunction with the tournament committee will choose the goal to be used.
 - Toss of coin: The Visiting team calls the toss. The team which wins the toss has the choice to take or defend the first shoot-out.
1. The team scoring or awarded the most goals is the winner and the competition ceases once an outright winner is determined. Winner is declared: when there is a clear winner and play is not necessary to finish the group of 5. Ex: during the 1st group of five 1v1 scenarios, the score is 4-1, there is no need to play out the last two players.
- a. PLAYERS AND COACHES—
 - When not involved in play, the Goalkeeper may stand on the end line on the side of the goal closest to her team OR may stand behind the 25 yd. line with the 5 players involved in the shootout.
 - Team members, not involved in the shootout, and coaches may stand on the field, behind the 30 yr. line, 5-10 yards from the sideline.
 - PLAYERS should be ready for the next shootout, but not raced into the set up.
 - If the goalie is a shooter, she is considered a field player.
 - A player who has been excluded permanently (red card) from the field of play during that same match, cannot take part in a shoot-out competition.

V. Taking the shootout.

OFFICIALS:

1. Lead and Trail officials will call the shootout.
2. Lead official during regulation time will continue to be lead regardless of which goal is chosen.
3. Table official will keep time.
4. If Sectional games have a Certified Table official, the Table official will keep the time. If a Certified Official is not assigned to the table during Sectional games, the timer will turn her/his back to the field and start the 10 seconds with the official's whistle. The official time will be kept on the field.
 - a. Officials should not feel they have to move the 1v1 along, scan both benches, allowing players and coaches a reasonable amount of time to set up for each shootout.

Field Hockey Overtime Procedures (cont.)

- The goalkeeper starts on or behind the goal line between the posts.
- The ball is placed on the nearest 25 yd. line opposite the center of the goal.
- The attacker stands outside the 25 yd. line near the ball.
- The umpire blows the whistle to signal the start of the shootout; the attacker and the goalkeeper may then move in any direction.
- The shoot-out is completed under the following conditions:
 - 10 seconds has elapsed (The trail official keeps the time.)
 - The attacker scores a goal
 - The attacker commits a foul
 - The goalkeeper commits an unintentional foul in which case the shoot-out is re-taken
 - The goalkeeper commits an intentional foul, in which case a penalty stroke is awarded
 - The ball goes out of play over the back-line or side-line; this includes the goalkeeper intentionally playing the ball over the back-line (not a foul). The ball simply going outside the circle a second time does not constitute the end of a shoot-out.

Replacement situations:

- If a penalty stroke is awarded as specified above, it is taken by the two players involved in the shoot-out concerned, unless either of them is incapacitated or suspended. This penalty stroke will take place before the next available shoot-out takes place.
- If during a shoot-out competition a player (either an attacker or goalkeeper) is suspended, that player takes no further part in that shootout competition and, unless a defending goalkeeper, cannot be replaced. The goalkeeper may be replaced by a goalkeeper from the bench. The replacement goalkeeper is allowed reasonable time to put on protective equipment.
- If the replacement goalkeeper is a field player, that player is allowed reasonable time to put on protective equipment.
- If an attacker is suspended during the shoot-out competition, there is no replacement allowed. Any further shoot-out the player was entitled to take counts as no goal; the shoot-outs taken by this player and scored being suspended, count as a goal.
- If during a shoot-out competition, a defending goalkeeper is incapacitated, that goalkeeper may be replaced by another goalkeeper.
- If during the shoot-out competition, an attacker is incapacitated, that attacker may be replaced by another player from the team unless suspended by the umpire prior to or during the shoot-out competition.

Field Hockey Overtime Procedures (cont.)

- VI. If a tie still exists after the first series of 5 shoot-out, a second series of 5 shoot-outs will take place. Coaches may change the order and/or players before the start of the second shootout.
- A coaching intermission lasting 2 minutes, will be allowed prior to the start of the second shoot-out period.
 - The coach must inform the umpires as to the order in which the nominated players take the shoot-out.
 - The team who had taken the first shoot-out of the first series must defend the second series.

If a tie still exists after a second series of 5 shootouts, additional series of shoot-outs are taken. Follow the same criteria as above.

- VII. Misconduct:
- If a player is green/yellow/red carded during the end of regulation time, their penalty will carry over into OT.
 - Green cards will carry a 2 minute penalty of playing time, Yellow cards will carry 5/10-minute penalty of playing time and teams will play short-handed with both cards.
 - During the OT when the game clock is not running, the timer will time the penalty. As time is not running between OT procedures, or during an official's time out, no time may accrue. The penalized player may return to the game after her 2/5/10 minute penalty has been served, at the next opportunity for substitution.
 - If an athlete is red-carded, that player is not eligible for any part of the overtime; the team does have to play short during the 7 v 7 plays.
 - It is expected that the players and coaches will not enter the field of play until the official has signaled the end of the game or overtime. Failure to comply will be treated as misconduct.

RULES AND REGULATIONS

2017 Section One Field Hockey Tournament

1. The 2017 Federation Rules will be used with substitutions allowed as outlined in the rule guide.
2. Fields should be properly lined (as in rulebook) and the front of the goal should be faced with wood painted white.
3. All spectators must be at least five yards away from the playing field at all times and it is **strongly** recommended that ropes be put up to help enforce this rule.

Forfeits: games must start within fifteen minutes of scheduled time unless an unforeseen circumstance occurs in which case both coaches, officials and, if necessary, the tournament chairman will determine a solution.

Ties: See Official State Tiebreaker

Protests: (see attached sheet) Judgment calls cannot be protested.

4. Home and Away socks are **required**. (H-light and A-dark). The higher seeded team will be the Home team.
5. Home and Away shirts are **required**. (H-light and A-dark). Numbers are **required**.
6. All Players on a team shall wear the same color compression shorts, undershirt and/or warm-up pants. *Undershirt for HOME team must be **WHITE**. No other color will be accepted. AWAY team must wear a **DARK** color undershirt similar to Away uniform top. Away team may not wear **WHITE** undershirts
7. The Goalkeeper shall wear a uniform on top of a color **CONTRASTING** to the color of the uniform tops of both teams and with a visible #.
8. All teams in the tournament are requested to provide a timer, a scorer, a clock, a stopwatch, a game ball, first aid supplies, your own practice balls, and any water or refreshments you might want.
9. Winning coach for each game should call:
 - a. Chairperson with results of the match **as soon as possible**.
 - b. Local newspaper and radio stations
10. The athletic director of the game site to be used will decide whether rain or field conditions are severe enough to postpone a scheduled game.

NFHS Field Hockey Rulebook Rule 4 Art. 3:

...Unless other state association rules apply, any tournament game interrupted due to events beyond the control of the responsible administration authority shall be completed as follows:

- a. If interrupted during the first half, the game shall be resumed at the point of interruption;
 - b. If interrupted after the start on the second half, the game could be resumed at the point of interruption, or by mutual agreement be considered a completed game.
11. All fields used for sectional play must meet the minimum standard for field length and width. This should also include the 5 yards needed on each side of the field for spectators and team players. The field must be in good playing condition, cut to regulation length with no major holes, divots and or standing water or mud. (See Rule 1 Section 2 "The Field and Markings" of the NFHS Field Hockey Rulebook).
 12. Higher seeded team may move the site of their sectional contest due to field conflict or field conditions with the permission of the Section One Coordinator and Section One Executive Director.

ALL LEAGUE AWARDS

This individual level award is chosen by the coaches within each league. Each school within the league has the ability to nominate athletes to this award. This award for each league is obtained with the following formula:

Leagues of 6 teams or less = 2 x's the number of starters

Leagues of 7 (2 x the number of starters x 2) divided by 1.5

Leagues of 8 (2 x the number of starters x 2) divided by 1.5

Leagues of 9 (2 x the number of starters x 2.25) divided by 1.5

Leagues of 10 (2 x the number of starters x 2.5) divided by 1.5

If a coach/rep is not present at the all league selection meeting, appropriate all league selections will be reserved for that school.

Suggestion - League of 6 teams, 22 soccer picks. 1st place to receive 7 picks, 2nd place to receive 5 picks, 3rd place to receive 4 picks, 4th place to receive 3 picks, 5th place to receive 2 picks, 6th place to receive 1 pick

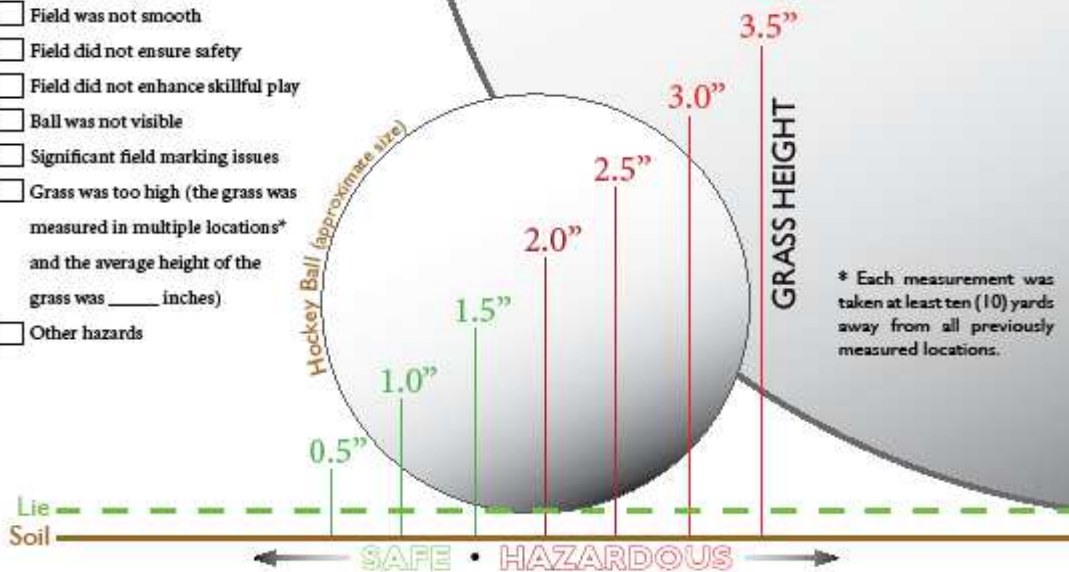
