CALL TO ORDER:

Calhoun Falls Charter School Board met in a scheduled meeting with Chairman Broadwell presiding. Mr. Broadwell called the meeting to order at 5:07 P. M.

INVOCATION:

Mrs. McCullough gave the invocation.

Mrs. Waters read the Mission Statement.

STAND OUT STUDENTS:

Mrs. Lindler had no presentation.

BUDGET REPORT:

Mr. Moser gave the Budget Report.

PUBLIC COMMENT PERIOD:

Rickey Holland questioned the policy concerning discipline of teachers who may physically touch a student. Mr. Broadwell stated that would be discussed during Executive Session. Mr. Holland asked for permission to address the board at that time, Mr. Broadwell answered yes.

Keith Ashley reminded board members to sell raffle tickets for the gun give away. The tickets should be turned in Yard Sale Day before 1:00 P. M. He also mentioned the sale of the banquet tickets.

APPROVAL OF LAST MONTH'S MINUTES:

Mrs. Gilchrist made motion to approve the minutes from the April 13, 2010 Board Meeting. Mr. Sorrow seconded the motion, with no opposition, motion passed.

PRINCIPAL'S REPORT:

Mrs. McCullough reported the PE Department sponsored a service learning project with free hot dogs. Coach Bomar supplied hot dogs and her students prepared them all day. The Art Show was held at Erskine recently with CFCS winning top honors. Mr. Sullivan was very proud of his students, Victoria Tatum won overall top honors and a \$100.00 prize. Mrs. Shea recently held the first ever middle school science fair with 3 winners, with prizes she donated.

Mrs. DeLoach's class presented projects based on novels they had read. There was a beautiful display in the library.

Mrs. McCullough praised faculty members for the time and money they give to CFCS academics and athletics.

Mrs. McCullough stated five students will graduate who have completed HOSA. She asked Ms. Edmunds to give a report on the students from health science. Ms. Edmunds stated after completing four units of health science her students take an exam, the scores were 85 to 91. She reported these students scored above the state and national levels. Mrs. McCullough praised Ms. Edmunds for the fund raising, travel and dedication she has shown.

Mrs. McCullough stated when CFCS began 12 positions were cut, salaries were cut, but programs were added. She stated the school has done more than ever with fewer faculty members and less pay.
