## **OLD BUSINESS:**

### **Coach Craigo Information and Discussion on Cancellation of Washington-Wilkes Game -**

Coach Craigo stated Mrs. McCullough had informed him the Board suggested the Washington-Wilkes game be cancelled. He stated he felt cancelling would be a mistake, the media would be after him for the reasoning behind the decision. Coach Craigo stated he had spoken with the WW coach who said the 5 home games they have scheduled are vital to their school. Mr. Broadwell stated the fee would be expensive and the decision would hurt our relationship with them. Chairman stated the decision is made, we will play.

**Discussion and Vote to Amend Policy Regarding Student Athletes –** Mr. Sorrow made motion to change the policy to state “Any student athlete who is formally charged with a felony will not be allowed to participate in any competition until all board requirements are fulfilled and board approval is issued.” Mr. Broadwell stated the athlete would be required to serve hours of community service, probation and if he/she gets in trouble eligibility may be revoked. Mrs. Waters stated a mentor to work closely with the student would be helpful. Mr. Sorrow made motion to amend the policy as stated above. He was seconded by Mr. Sammons. Motion passed unanimously.

Coach Craigo stated the VB coach had to resign because of a conflict with her schedule. After advertising Coach Turman has agreed to coach VB.
