Sacred Heart School has been blessed to have businesses participate in EITC (Educational Improvement Tax Credits) program this year! They have designated funds specifically for use as scholarships for our SHS families.

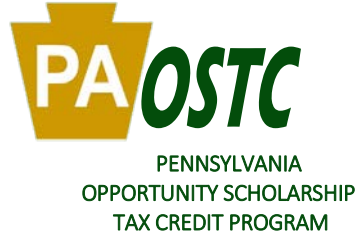
### **What does that mean to you?**

If you meet the qualifications for these funds, you could receive funds off your tuition. Distribution will be based on need and income. An EITC application must be completed online at <https://online.factsmgt.com/signin/3D9RB>. A copy of either of your last 2 year's Federal Income Tax Return (IRS form 1040, 1040A or 1040EZ) and W2's must be provided. If you do not receive W2's or filed Federal Taxes please contact the school office at 610-373-3316. ALL FINANCIAL information is kept confidential. The state of Pennsylvania sets minimum guidelines and requires complete confidentiality. Only the administrator oversees the EITC program. Sacred Heart School requires all families receiving money to adhere to all school policies and procedures, support SHS sponsored fundraisers and be current with tuition payments.

### **The 2018-2019 financial guidelines are as follows:**

Students whose household annual income is **no greater than \$77,648** plus \$15,530 for each dependent member of the household are eligible to apply for financial aid.  
(Ex. A family making \$100,000 or less with 3 dependents may be eligible for EITC funds.)

## PARENTS:

Students who ***live within the attendance boundaries of a low-achieving school***, (see below) as determined by the Pennsylvania Department of Education, are eligible to receive a scholarship if their household's annual income is ***no greater than \$77,648*** plus \$15,530 for each dependent member of the household. (Ex. A family making \$100,000 or less with 3 dependents may be eligible for OSTC funds.)
